The above limited warranty is in lieu of all other express warranties and representations. All implied warranties are limited to the applicable warranty period set forth above. Consequential and incidental damages resulting from the use of the Product or arising out of any breach of contract, or breach of warranty, are not recoverable under this limited warranty.
